If payment is not received within 5 business days of notification the applicant loses the bid and the next successful bidder will be notified. After payment is received, receipt of the purchase along with the signed, transferred and suspended logbook will be provided. Individuals will be given 48 hours to remove the acquired asset from WAC’s compound.
