Dispose of Waste Oil/Fuel the Proper Way

Over the last several months, the Water Authority has seen an increase of fuel and waste oil being improperly disposed of, in and around the water meter boxes. This poses a risk to the public water supply system.

Hydrocarbons such as gasoline, diesel, motor oil and kerosene are all considered hazardous materials and should never be disposed directly in or on the ground, in storm drains, waterways and Water Authority meter boxes. If a meter box is exposed to these contaminants, the Authority will clean it up to protect the water supply system. It takes substantial resources to clean up hydrocarbons from contaminated sites, including testing samples, and replacing equipment such as service lines. All this comes at a high cost, which will be passed on to the customer.

To avoid this, the Authority strongly urges its customers to do their part to protect the environment by following guidelines laid out by the Department of Environmental Health to store and dispose of hydrocarbons properly. All hydrocarbons should be stored in containers specially designed for this purpose; do not use empty

water bottles, plastic containers or containers that are left open. Hazardous waste must be separated from regular household garbage and dropped off at the landfill in the designated storage area for all hazardous materials so that it can be processed for proper disposal overseas.

If you suspect your water supply may be contaminated with hydrocarbons, please contact the Water Authority immediately.

YOUR JANUARY BILL EXPLAINED All monthly water bills are made up of three components: a meter rental fee, an Energy Adjustment Factor (EAF), & your usage.

January bills may be higher due to increased usage over the holidays as a result of entertaining guests or having children home from school. However, even if your daily usage did not increase significantly over the holiday period, your January bill will normally be higher because it covers a longer meter reading period than your December bill, which covers a shorter meter reading period due to the Christmas and New Year holidavs.

Although the Water Authority makes every effort to identify anomalies in your consumption history and double-checks all bills flagged for review by our billing system, we also encourage you to monitor your own usage and be aware of changes in your daily life that could impact how much water your household uses.
